## A. Speech/Play Production

#### **ARTICLE XVII, SECTION II**

The conference will form a committee at the end of the school year to hire judges for the conference speech and one-act play production meet for the following year. The committee would consist of the coaches or contest directors from the prior year, current year, and following year. Since there is a separate speech contest and one act play production for each division, there would be two separate committees. The directors for Speech and Play Production will be responsible for making site arrangements, contracting registered judges, and preparing the schedule of activities for the day.

**Proposal:** The conference will appoint directors to hire judges for the conference speech and one-act play production contests. The directors for speech and play production will be responsible for making site arrangements, contracting registered judges, and preparing the schedule of activities for the separate contests.

**Rationale:** The speech and play production people couldn't get together with the previous, current, and future holders of the tournaments. This is what we are currently doing anyway. Currently the committee consists of AJ Johnson from Hartington, Ronda Ras from Bancroft-Rosalie, and Brad Hoesing from Wausa. The reasons for revising the constitution as follows:

- 1. It provides consistency year to year in both play production and speech in officials, tournament hosting and running of the events.
- It gives actual administrative control to the directors when fielding questions about the speech and/or play production contests.
  It assists schools not used to hosting big contests consistency and aid. (THIS IS THE SECOND READING FOR CONSTITUTIONAL REVISION).

## B. Appoint officers for 2013-2014.

Appoint Officers for 2011-2012 (Artilce V. Section I). Consider, discuss, and take all necessary action to appoint 2013-2014 L & C Conference Officers. Wynot, is the current president-elect (Joey Lefdal). The Treasurer must be from the same school. The secretary shall be appointed by the membership of the Conference and shall serve until such time as the Conference shall deem necessary.
