Activity-
Band and Choir

Proposal-

We need to buy 3 sets of music per song for band and 200 sets per song for choir to make sure we comply with NSAA policy and copyright laws.

Should a song selected from the library have insufficient copies the director can order the appropriate number of copies needed to cover copyright laws (up to 200).

To comply with NSAA policy and copyright law, the host school must mail physical copies to the conference schools. On the reimbursement form, postage needs to be included.

Attachment D

Activity-
Wrestling

Questions-

Class C and D now have different rules regarding varsity wrestlers. Class D can fill weights with 14 varsity wrestlers with 2 allowed per weight. Class C can only enter 1 competitor at each weight. Entries may be unbalanced toward D schools.

Proposal-

We propose that Class C schools be allowed to reflect the Class D rules and fill up to 14 varsity spots with a maximum of 2 wrestlers per weight. All schools with multiple wrestlers at certain weights will then select only one scorer per weight. This will allow all Class C and D schools to have potentially equal numbers in their varsity line-ups.

Rationale-

Half of our conference's schools are Class C and would be at a disadvantage. Class D schools could take multiple spots as All-conference while other Class C teams cannot.

Attachment E

Activity-
Speech/One Act

Proposal-
Allow students in Class C-2 and above to be triple entered at the conference speech meet.

Rationale-
Our constitution currently states that the conference meet will be run in the same format as district speech meets. Last April, the NSAA voted to change the rules for district entries for Classes D1 and D2. Previously, students in all classes were allowed to be double entered only. Now, students in Classes D1 and D2 will be allowed to be triple entered. This proposal will allow all students at the conference meet to be triple entered.

Cost-
This should not affect the cost of the conference meet. We may have some more entries, but we should be able to handle them with the judges we have hired. We may have to extend the length of the day some.
